Mike is the owner of Mold Testing Services, LLC (MTS). He has a Master of Science degree and more than 30 years experience in environmental concerns. He worked for 2 years for the Iowa Geological Survey as a field geologist and for 10 years with the SD Dept Environment of Natural Resources as a hydrogeologist (Hydrologist III). He then worked for a local consulting firm in Sioux Falls for 20 years. During that time he developed their indoor air quality (IAQ) and mold program. Mike has 14 years experience in IAQ and mold investigations. For the last two years, he has been doing IAQ and mold testing for MTS. He has worked on more than 1000 sites including

houses, offices, apartments, hotels, schools, hospitals and businesses. He is a certified microbial investigator (CMI – ACAC) and has certifications in water damage restoration and mold remediation by the IICRC (WRT and AMRT). He has worked with many cleaning firms on before and after mold clean-ups at hundreds of sites. In 2009 he presented a paper at the 2009 Indoor Air international conference on normal and problem indoor airborne mold in more than 300 buildings.

Mike's talk will address a variety of indoor air quality and HVAC concerns including mold and moisture damage, odors and common HVAC problems.
